#### Truck and Treat, 2020:

Attached to this report, you will see a flyer for this year's event. As I stated, the last meeting this year, Trunk and Treat will be a "drive through" event held here at the City Park. Planning is underway as we speak. The groups working together on this are Algona and Pacific, ALPAC Elementry PTA, Home Town Community Services, and Pacific Partnerships.

#### **Body Camera Updated:**

All the body cameras have been deployed, and all the officers are using them. If you have not had a chance to take a look at social media, I will be posting one short video a week to highlight the use of the cameras as well as benefit to the community.

#### **Traffic Stats and Education:**

Attached to this report is a copy of the traffic stats for September. As part of our ongoing traffic education efforts, we have purchased a replacement for the speed sign that was stolen from Algona Blvd. This new sign will be more mobile and easier to move around the City and complement our larger reader board speed signs.



#### **Budget Items for Consideration:**

Also attached to this report are two items that impact the City's budget. The two items are the 2021 rates for SCORE Jail and the 2021 rates for Valley Communications Center. The mayor wanted the council to be aware of the new rates before he signed the agreements.

#### Follow up:

During the budget retreat, the idea of designating the entire City of Algona as a Rail Road Quite zone was discussed. Since that meeting, I have directed Sgt Miller to began researching this notion and provide a written report as well as a presentation to the council. As part of the preliminary research, we contacted the City of Kent. We have also contacted the Nationa Rail Road Commission, which has many guidelines and useful information on the topic on their webpage.

wanted to thank you all for attending the Budget Retreat; it was a success and everyone was able to present their requests, "wish lists", goals and proposals for next year's budget. Following MRSC's calendar for the Budget process we will need to complete the following with suggested dates;

## Community Center:

Food Donations- Gary was able to make contact with an agency in Federal Way who are able to provide us with "Food Boxes" to the community. Friday Gary delivered these boxes to families and seniors in Algona, he delivered 20 full "Food Boxes" and 10 ½ full "Food Boxes". Attached is a photo of what was included in the boxes of items that were donated, and he will continue to go pick up supplies on Thursday's for as long as they are available.

Pumpkin Patch- Saturday November 17<sup>th</sup>, we will be having our "Pumpkin Patch" for our citizens. Gary has it planned out the event with social distancing requirements in mind and hopes for it to be successful. Any leftover pumpkins will be available to for others to come and pick up at the Community Center.

Trunk or Treat- We will be working with Alpac Elementary along with the A-Team for this event that will be on Saturday, October 31, 2020. Both Gary and the Police Chief have been working together to figure out the details and from what I've heard, it going to be a fun, great event.

#### Public Works:

Salvador ordered the last 3 hydrants that need to be replaced in our system. This purchase was approved in 2020's Budget. The budget was for \$30,000 and they only spent approximately \$14,000 on the hydrant parts..

They are beginning to ramp up winterizing to help eliminate or decrease any chances of frozen pipes and leaks.

#### Administrative:

Starting next week, I will be attending weekly training until March 1, 2021 with the Northwest Clerk's Association. After it is completed, I will be able to submit all my training and documentation required for "Certified Municipal Clerk", CMC. This is significant and important to the city, as both Laurie Cassel and Diana Quinn are no longer here, and having someone on staff who possess an CMC would only be beneficial to the City of Algona.

# DECLARING OCTOBER 2020 "DOMESTIC VIOLENCE AWARENESS MONTH" IN THE CITY OF ALGONA

**WHEREAS**, Domestic violence has affected members of our community and individuals throughout the world. Sadly, many victims of this crime suffer in silence because they are afraid to seek help. It is crucial that members of our community feel safe, and comfortable seeking help when needed; and

WHEREAS, It is estimated that more than 10 million people experience domestic violence every year. While domestic violence is known primarily as physical abuse, it has many other forms including emotional, sexual, financial, or psychological. It can cause long-term trauma to individuals of every gender, sexual orientation, race, religion, culture, and socioeconomic status; and

**WHEREAS**, Since the beginning of the COVID-19 Pandemic, Washington has seen an increase in reports of domestic violence and abuse especially in the King and Pierce County regions. A contributing factor to the increase is more people are staying home. Although home is a sanctuary for most of us, it can be the most dangerous place for victims of domestic violence; and

**WHEREAS**, Domestic Violence Awareness Month is nationally recognized every October, and first began by the National Coalition Against Domestic Violence as a Day of Unity to connect women's advocates across the country. This month is an opportunity to help our community promote and protect the safety and freedom of all who seek refuge from this terrible crime; and

**WHEREAS**, Your Algona Pacific Domestic Violence Task Force and the Algona Police Department are dedicated to help victims of domestic violence by providing resources to advocacy, education, and services. Through various programs throughout our region, individuals and families can feel a sense of hope, safety, and protection; and

**WHEREAS**, The City of Algona encourages members of the community to work together to increase domestic violence awareness. Doing so will enable members of our community to feel safe and secure.

NOW, THEREFORE, the Mayor and Councilmembers of the City of Algona, do hereby proclaim October, 2020 to be Domestic Violence Awareness Month.
