Algona City Council Council Meeting January 11, 2021



Mayor Hill called the meeting to order at 7:00 PM. He initiated the flag salute. Roll call was taken. Council members, Troy Linnell, William Thomas, Dawn Dofelmire, Mike Dawkins and Lynda Osborn were present. Staff members present were James Schrimpsher – Police Chief, Jimmy Griess – Public Works Director, and Jessica Griess – Acting City Clerk.

PUBLIC HEARING – No comments made on outdoor dining.

<u>MAYOR PRO TEM APPOINTMENT</u> — Council Member Osborn nominated Council Member Linnell as Mayor Pro Tem. Council Member Thomas seconded the nomination. Mayor Hill asked if there were any other nominations. When none were brought forward, he closed the nominations then asked for a vote from the council. The vote was a unanimous yes.

DISCUSSION -

A. Ordinance 1185-21, An Ordinance of the City Council of the City of Algona, Washington, Amending Chapter 2.50 AMC Fee Schedule; Updating and Increasing the City's Rates for Sanitary Sewer Service; Providing for Severability; and Establishing an Effective Date.

Jimmy Griess addressed the Council. King County Sanitary Sewer Services sent out a notice to Diana's email almost a year ago notifying of a rate increase in 2021. Julie noticed the change and realized the city's rates would need to be updated as well. The rate increase will be \$2.04. It must be passed by the next council meeting in order to bill with the new rate for January. Zach confirmed that waving the triple review by the Council would be recommended and allowed in this case to ensure the rate schedule can be effective for the January billing.

B. Finance Committee Creation

The Mayor has asked for the creation of a Finance Committee made up of himself, a staff member, and a Council member. This committee can be a more ad hoc approach or meet on a regular basis. The committee can also just be an overseer with no authority to avoid the open government requirement. The Mayor suggested a standing committee as well. The Council would like to move forward with the standing committee option.

C. 2021 Stormwater Management Program

Only updates from 2020, is the timelines. The new dates are in the 2021 Stormwater Management Program.

A. Council Member Thomas moved to approve Ordinance 1184-21 and Council Member Linnell seconded it. Ordinance passed with a unanimous vote in favor.

B. Resolution 1227-21, A Resolution of the City of Algona, Washington, Approving an Agreement with Tara Dunford, CPA, for Accounting Services and Authorizing the Mayor to Execute the Agreement.

Council Member Dawkins moved to approve Resolution 1227-21 and Council Member Thomas seconded it. Resolution passed with a unanimous vote in favor.

EXECUTIVE SESSION -

The Council broke into an executive session to discuss potential litigation with legal counsel pursuant to RCW 42.30.110(1)(i).
