WHEREAS, the Parties executed that certain Consultant Agreement dated April 23, 2018 ("the Agreement") for the provision of legal services; and

WHEREAS, the Parties subsequently executed a First Addendum to the Agreement in order to adjust the fee schedule for 2019; and

WHEREAS, the Parties subsequently executed a Second Addendum to the Agreement in order to adjust the fee schedule for 2020; and

WHEREAS, the Parties desire to continue and amend the Agreement by updating the fee schedule attached hereto;

NOW, THEREFORE, IN CONSIDERATION OF the mutual promises, terms and conditions set forth in the Agreement and contained herein, the Parties hereby agree as follows:
