RESOLUTION NO. 1248-22

A RESOLUTION OF THE CITY OF ALGONA, WASHINGTON, FIXING A DATE FOR A PUBLIC HEARING TO CONSIDER VACATING A PORTION OF 7TH AVENUE NORTH, 8TH AVENUE NORTH, 9TH AVENUE NORTH, AND 59TH AVENUE SOUTH.

WHEREAS, the City has received a petition to vacate a portion of 7th Avenue North, 8th Avenue North, 9th Avenue North, and 59th Avenue South from King County, the owner of Property Tax Lot Nos. 375160-1414, 375160-1416, 335640-7905, 375160-1419, 335640-7925, 375160-1429, 335640-7905, 335640-7910, and 335640-7890, adjacent to the subject portions of right-of-way, pursuant to Chapter 35.79 RCW;

WHEREAS, in accordance with RCW 35.79.010, the petition has been signed by more than two-thirds of the owners of the parcels abutting the portion of the street right-of-way areas proposed to be vacated, and the petition is now being forwarded to the City Council to set a date for a public hearing on the proposed vacation.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ALGONA DO RESOLVE AS FOLLOWS:

- **Section 1.** Pursuant to RCW 35.79.010, the date and time of September 26, 2022, at 7:00 PM, or as soon thereafter as the matter may be heard, is hereby established as the date on which the Algona City Council will hold a public hearing to consider the proposed vacation of a portion of 7th Avenue North, 8th Avenue North, 9th Avenue North, and 59th Avenue South, depicted on the attached drawing (Exhibit A). The hearing will be held as part of the regular City Council meeting at Algona City Hall, in the Council Chambers, located at 200 Washington Boulevard, Algona, Washington.t
- **Section 2.** Pursuant to RCW 35.79.020, the City Clerk is hereby directed to give at least 20 days' notice of the date, time, location, and purpose of the public hearing by: (a) publishing written notice once in the City's official newspaper; (b) posting a placard in a conspicuous place on the street sought to be vacated; and (c) posting written notice in three prominent public places throughout the city.
- **Section 3.** This resolution shall take effect immediately upon passage.


