#### RIGHT-OF-WAY DEDICATION DEED

The Grantor, KING COUNTY, a political subdivision of the State of Washington, for and in consideration of regulatory approval, and other valuable consideration, hereby conveys, grants and dedicates to the CITY OF ALGONA, a municipal corporation of the State of Washington, and its assigns, a permanent public right-of-way, to be used for all lawful right-of-way purposes, surface and subsurface, including without limitation the construction, installation, operation, maintenance and repair of streets, sidewalks, plantings, right-of-way beautification improvements, utilities, stormwater conveyance, retention and/or detention facilities, signalization, signage, and such other appropriate municipal right-of-way uses from time to time, now or in the future, for the use and benefit of the public, over, under, upon and across the hereinafter described lands:

See Exhibit A for the right-of-way legal description and Exhibit B for right-of-way depiction, said exhibits attached hereto and incorporated herein by reference as if set forth in full.

The Grantor warrants that it has all right, title and authority to make such conveyance, grant and dedication. The rights herein granted shall run with the land and shall be binding upon and inure to the benefit of the parties' successors and assigns.

#### LEGAL DESCRIPTION

THAT PORTION OF LOT 1 AND LOT 2, BLOCK 127, AND ABUTTING VACATED 8<sup>TH</sup> AVE NORTH LOCATED WITHIN CD HILLMAN'S PACIFIC CITY ADDITION TO THE CITY OF SEATTLE, DIVISION NO. 6, ACCORDING TO THE PLAT THEREOF RECORDED IN VOLUME 14 OF PLATS, PAGE 30, RECORDS OF THE KING COUNTY RECORDER MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE MOST EASTERLY CORNER COMMON TO BOTH LOT 1 AND LOT 2 OF SAID BLOCK 127, ON THE WESTERLY RIGHT-OF-WAY MARGIN OF DETROIT BOULEVARD AS SHOWN ON THE RECORD OF SURVEY BY KING COUNTY ROAD SERVICES DIVISION FILED UNDER RECORDING NUMBER 20120619900001;

THENCE ALONG SAID WESTERLY RIGHT-OF-WAY MARGIN, SOUTH 07°58'25" WEST 123.20 FEET TO THE INTERSECTION WITH A CIRCULAR CURVE TO THE LEFT, HAVING A RADIUS OF 800.00 FEET, THE CENTER OF WHICH BEARS NORTH 86°02'27" WEST;

THENCE NORTHERLY ALONG SAID CURVE TO THE LEFT, THROUGH A CENTRAL ANGLE OF 11°54'27" AN ARC DISTANCE OF 166.26 FEET TO THE INTERSECTION WITH THE WESTERLY RIGHT-OF-WAY MARGIN OF SAID DETROIT BOULEVARD AT A POINT THAT IS 4.04 FEET NORTHWESTERLY FROM THE NORTHEAST CORNER OF SAID LOT 1, BLOCK 127;

THENCE ALONG SAID WESTERLY RIGHT-OF-WAY MARGIN OF DETROIT BOULEVARD WITHIN VACATED 8<sup>th</sup> AVE NORTH AND SAID BLOCK 127, SOUTH 12°44'35 EAST 198.38 feet TO THE POINT OF BEGINNING.

SITUATE IN THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 23, TOWNSHIP 21 NORTH, RANGE 4 EAST, WILLAMETTE MERIDIAN, IN THE CITY OF ALGONA, COUNTY OF KING, STATE OF WASHINGTON.
