RESOLUTION NO. 1259-23

A RESOLUTION OF THE CITY OF ALGONA, WASHINGTON, FIXING A DATE FOR A PUBLIC HEARING TO CONSIDER VACATING A PORTION OF THE 1st AVENUE NORTH PUBLIC RIGHT-OF-WAY.

WHEREAS, pursuant to Chapter 35.79 RCW, the City has received a petition to vacate a portion of 1st Avenue North from and on behalf of Algona View Investment, LLC, the owner of Property Tax Lot No. 3356407842, which property is immediately adjacent to the subject portion of right-of-way; and

WHEREAS, in accordance with RCW 35.79.010, the petition has been signed by more than two-thirds of the owners of the parcels abutting the portion of the right-of-way area proposed to be vacated, and the petition is now being forwarded to the City Council to set a date for a public hearing on the proposed vacation;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ALGONA DO RESOLVE AS FOLLOWS:

Section 1. <u>Public Hearing</u>. Pursuant to RCW 35.79.010, the date and time of August 28, 2023, at 7:00 PM, or as soon thereafter as the matter may be heard, is hereby established as the date on which the Algona City Council will hold a public hearing to consider the proposed vacation of a portion of 1st Avenue North as depicted in Exhibit A, attached hereto and incorporated herein by this reference as if set forth in full. The hearing will be held as part of the regular City Council meeting at Algona City Hall, in the Council Chambers, located at 200 Washington Boulevard, Algona, Washington.

Section 2. <u>Notice</u>. In accordance with RCW 35.79.020, the City Clerk is hereby directed to provide at least twenty (20) days' notice of the date, time, location, and purpose of the above-referenced public hearing by: (a) publishing once in the City's official newspaper; (b) posting in a conspicuous place on the street portion proposed to be vacated; (c) posting in three (3) prominent public places throughout the City; and (d) mailing to all owners or reputed owners of property abutting upon the street portion proposed to be vacated, as shown on the rolls of the King County Treasurer, and directed to the addresses thereon shown.

Section 3. <u>Effective Date</u>. This resolution shall take effect immediately upon passage.



ORDINANCE NO. 1221-23

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ALGONA, WASHINGTON, AMENDING CHAPTER 2.52 AMC <u>SALARIES</u>; ALLOWING THE SALARY OF THE MAYOR TO BE SET EITHER THROUGH THE CITY'S ANNUAL BUDGET ADOPTION PROCESS OR THROUGH A BUDGET AMENDMENT; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, pursuant to applicable state law, including without limitation RCW 35A.12.070, the salary of the mayor shall be fixed by ordinance and may be revised from time to time by ordinance; and

WHEREAS, the City has adopted standards and procedures for adjusting the salary of the mayor, and has codified the same at Chapter 2.52 AMC; and

WHEREAS, the City Council wishes to amend Chapter 2.52 AMC to clarify that the salary of the Mayor may be adjusted either through the City's annual budget adoption process or in conjunction with a mid-year budget amendment;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ALGONA DO ORDAIN AS FOLLOWS:

Section 1. Amendment of AMC 2.52.040. Section 2.52.040 of the

Algona Municipal Code is hereby amended to provide in its entirety as follows:

The salary of the mayor shall <u>either</u> be set annually at the time of adoption of the budget by the city council <u>or in</u> <u>conjunction with an amendment of the budget</u>, and shall be recorded in the budget <u>or budget amendment</u> ordinance.

Section 2. Severability. Should any section, paragraph, sentence,

clause or phrase of this ordinance, or its application to any person or circumstance, be

declared unconstitutional or otherwise invalid for any reason, or should any portion of

this ordinance be pre-empted by state or federal law or regulation, such decision or preemption shall not affect the validity of the remaining portions of this ordinance or its application to other persons or circumstances.

Section 3. <u>Effective Date</u>. This ordinance shall be published in the official newspaper of the City and shall take effect and be in full force five (5) days after the date of publication.
