Russ - Tacoma Blvd Water Main Replacement Project is complete. Just finishing the cleanup work. I am still working on getting a quote for the lift station. We did receive a franchise application from Ziply fiber. They are an internet provider. We will bringing forward a resolution at the next meeting for Council to set the application fee. Once they pay the application, we can begin negotiating a franchise agreement. All the costs associated are passed on to the applicant.

Chief Schrimpsher - We received a grant to fully fund an extra officer for the next three years. Working through the documentation and there's no match requirement. An offer of employment has been made and they will be starting the academy December 13th. Officer Greve's replacement will be starting this week. Officer Johnson's replacement has already started. Operation Blue Christmas is being worked on. Looks like there will be seven

families. Thank you to those that have donated. It's nice seeing the community reach out and help. Finished our last training event for the year.

City Administrator Griess - December 9th, is a busy day: Elected Officials Essentials training, Blue Christmas, and the Tree Lighting event. We are still accepting donations for Blue Christmas. Our phones have been down for two weeks now. Current provider has an upgrade option to get us away from the analog lines to fiber. Looking into using Microsoft Teams instead. Just waiting on CenturyLink to fix the line. Russ and I met with Emily from our city attorney's office. She is working on the Comcast agreement and we are going to start researching a PEG fee that would pay for an upgraded system for Channel 21.

Mayor Linnell - Update on the house being cleaned up on Tacoma Blvd. We've been working with them since June and they did not get it cleaned up by the agreed upon date. We will be moving forward with legal action.

Christy Rodriguez, Milwaukee Blvd - Following up the Mayor's comments on the four way stop. Took the time to look at the traffic model code. WAC 308.330.260 Traffic Engineer - states we can appoint an engineer, who is appointed for the City? And if someone is appointed, why pay for the consultant? RCW 46.90.010 - You cannot make up your own rules. WAC 308.330.800 and RCW 47.39.110 state that safety stop signs can be put up in line with regulations. AMC 12.04.060 Design Criteria - explains how best practices should be used for street design. This intersection continues to be a problem, and data shows there haven't been any accidents until the four-way stop was put in. At least that I can find. This continues to put citizens at risk. When will we expect the temporary stop signs to be removed? Lastly, being a leader means taking action, responding, and being humble, I have yet to see this from you. I hope you learn from this and be leaders of the city. Until this happens, I will expect to receive the responses, and the reason people do not attend meetings because they don't want to be belittled. I am requesting the Council's response to the four-way stop.

Council Member Thomas - Ms. Rodriguez asked for responses, but given no avenue to do so. Regardless, there's good comments made about the four way stop, but also some quite vindictive comments were made. It's been proven to work now and it is for public safety, not just to slow people down. There's sight line distant issues there, that's why I accepted it.
